Product description

- Enriched organic fertilizer; NPK 10-1-3 + 2 CaO (PFC1AI)
- Product is made of animal and vegetal raw materials
- 100% natural, no chemical or other additives
- High percentage of stable organic matter

General application advice

- Apply 7-10 days prior to sowing or planting and mix with the top layer of the soil
- In planted areas, apply as a top or row fertilization at 15-20 cm from the roots
- Apply before rain or use irrigation after application
- Spread applications if necessary. This depends on the type of crop and the amount of fertilizer needed.

Storage conditions

- Store in a dark, cool but frost-free and dry place
- Keep away from water and moisture
- Do not store together with food products
- Shelf life is minimal three years after the production date and can be longer when stored correctly

Safety and environment

- Not intended for ingestion. Wash hands after use. Don't breath in dust

- Keep away from children and pets
